PARENTS ARE THE PRIMARY LIFEGUARD FOR THEIR CHILDREN

1. Only bathing suits may be worn in pool.
2. Guests must be accompanied by a member at all times while in facility.
3. Diving is allowed only within diving area. Only one (1) person is allowed on diving board at one time.
4. Age limit: Three (3) years in baby pool.
5. Age limit: Ten (10) years in Activity Pool.
6. No swimming unless lifeguard is on duty.
7. All swimmers must shower before entering the pool.
8. No glass containers permitted in the facility. No food or beverages allowed in the pool area.
9. Children under the age of ten (10) must be accompanied at all times by a parent or guardian over the age of eighteen (18).
10. Diaper changing permitted in restrooms only. No disposable diapers are permitted in pool. Swim diapers only permitted in pool.
11. No pets permitted.
12. No running, horseplay or loud and unruly conduct.
13. Flotation devices and toys may be subject to approval by lifeguard on duty.
14. Persons with open wounds will not be allowed in pool.
15. Lanes may be restricted for lap swim only as determined by pool management.
16. Only swimmers 18 years or older are allowed in the pool during Adult Swim (10 minute safety break). Splash pad and activity pool closed to all during Adult Swim. The only exception will be diaper age children, accompanied by a parent, in the baby pool.
17. In case of emergency, notify lifeguard personnel on duty or call 911.
18. Association ID cards must be shown on demand.
19. Cooking in designated area only.
20. This is an alcohol and tobacco free facility.
- 21. Slide Height restriction – Must be 42' and over to use slides in the main pool area.**

BEACH CLUB BOAT CHECK OUT RULES

1. **BOATING IS AT YOUR OWN RISK. NO LIFEGUARD IS PROVIDED.**
2. Boaters must be familiar with Boating and Lake Rules.
3. Members must present Cinco Ranch I.D. card to check out boats.
4. Members checking out sailboats must be approved by the Beach Club dock personnel.
5. Guests must be accompanied by a member at all times.
6. Children under the age of twelve (12) must be accompanied by a parent or guardian over the age of eighteen (18) while boating on the lake.
7. Boat usage is limited to one (1) hour.
8. No more than two (2) persons are allowed in any sailboat.
9. No more than four (4) persons are allowed in any paddleboat.
10. Coast Guard approved life vests must be worn at all times by all persons in a boat.
11. No boats will be checked out within thirty (30) minutes of closing time, or during inclement weather.
12. Members shall be held responsible for any damage to boats, boat equipment, and/or personal injury caused by members or their guests. Boating privileges may be revoked for causing such damage or injury.
13. This is an alcohol and tobacco free facility.

BOATING AND LAKE RULES**

1. **BOATING AND LAKE USAGE IS AT YOUR OWN RISK. NO LIFEGUARD IS PROVIDED.**
2. Persons who sail on the lake must be approved by the Beach Club dock personnel.
3. Guests must be accompanied by a member at all times.
4. Children under the age of twelve (12) must be accompanied by a parent or guardian over the age of eighteen (18) while on the lake.
5. Coast Guard approved life vests must be worn at all times by all persons in a boat.
6. Boats are not allowed on the lake during inclement weather or after dark.
7. Use of the boat launch restricted to Beach Club hours of operation.
8. Boats must remain at least ten feet (10') away from the lake fountain(s).
9. No standing, jumping, horseplay, or bumping of boats is allowed.
10. No swimming, diving or wading is permitted in the lake.
11. Overnight mooring of boats on the lake is prohibited.
12. Animals (including waterfowl) are not permitted in the lake.
13. Fishing by rod and reel is permitted from the shoreline only.
14. Chemicals, fertilizers or pesticides may not be used within ten feet (10') from the lake to minimize harmful run off.
15. Lake water may not be drawn for any private use.
16. Member's boats must be approved by the Beach Club dock personnel. Minimum requirements are:
 - a. No motorized watercraft
 - b. No boats over 16' in length
 - c. No windsurfers

TENNIS COURT RULES

1. Use of the courts is restricted to members of Cinco Residential Property Association and their guests. A guest **MUST** be accompanied by a member at all times.
2. **The courts are restricted to tennis playing only.** No bicycles, skateboards, skates, pets or other items not relating directly to tennis will be allowed on the courts.
3. Shirts and proper tennis shoes are required at all times while on the courts.
4. No glass containers permitted on the courts.
5. Good sportsmanship is expected at all times. Please refrain from use of profanity and loud outbursts.
6. Reservations recommended. Play time on unreserved courts is limited to one (1) hour and is available on a first come first serve basis. No one may play consecutively while others are waiting.
7. Tennis court doors may not be propped open with towels, t-shirts, rocks, etc, as this may, in time, damage the door systems.

Lights are set on a Master Timer, set to turn on at 5:30 pm and turn off at 10:00 pm. West Side Courts 3 & 4 lights turn off at 9:00 PM due to homes located behind tennis courts.

Court Reservation Rules

1. Tennis court hours are from 6:30 a.m. - 10:00 p.m., with the exception of Westside Courts 3 & 4. These courts close at 9:00 p.m. and the lights are on a timer to go off at this time.
2. Court reservations may be made between 9:00 a.m. and 11:00 p.m.. Same day reservations will not be allowed.
3. A maximum of 2 hours per household per day
4. Reservation can only be made 14 days in advance
5. Cinco Ranch residents are allowed to bring up to four (4) guests per household
6. A maximum of four (4) players may be on a court at any time.
7. Two courts in Cinco Ranch must be open for Resident Play at all times. On Mondays, Wednesdays, Fridays, and Saturdays, two courts must be open for Open Play reservations between 5:00 - 8:00 p.m. This does not pertain to league make up games due to weather related cancellations.
8. All courts that are reserved by residents, league play or social play need to be utilized by those groups. If courts are not used within fifteen (15) minutes of scheduled start time and used for the allotted time, those courts will be forfeited

for that particular day to other residents who wish to play. Repeated non-utilization of reserved courts, not cancelled in a timely manner on consecutive days or weeks, may result in a penalty to an individual or group, including but not limited to loss of reservation privileges.

10. All gates that require key cards to gain access to restricted areas need to remain closed at all times. Please do not use towels, t-shirts, rocks or any other items to keep the door open, as this may, in time, damage the system from optimal performance, resulting in replacing the system. Repair/replacement costs to the system will be forwarded to the Association and ultimately to all the residents of Cinco Ranch.
